1. REQUIREMENTS FOR APPLICATION OF NAMIBIAN CITIZENSHIP BY DESCENT

NB: Incomplete forms and outstanding documents will cause unnecessary delays. All copies must be certified by Namibian Police. Only applicant himself herself for legal guardian is dully allowed to sign the application form.

FORMS AND DOCUMENTS REQUIRED:

- Certified copy of the applicant's Full Birth Certificate and Namibian ID if in possession of such ID
- Certified Copies of both parent's Identity and Birth Certificate
- Copy of Repatriation form (if he/she was born in exile during the Liberation Struggle)
- If such Repatriation is lost or impossible to get, a declaration from parents or guardian made from the Namibian Police.
- And a letter from SWAPO Party Office, confirming that the child was born in exile (in case of those born in exile)
