# RENEWAL OF EMPLOYMENT PERMIT (REP): FORMS AND DOCUMENTS REQUIRED

## NB:

- 1. No application forms will be accepted if all necessary documents are not provided
- 2. Incomplete forms and outstanding documents will cause unnecessary delays.
- 3. All documents must be in English or translated into English
- 4. All copies from applicant must be certified
- 5. All application forms to be signed by the applicants themselves.

## 1. TO BE COMPLETED AND SUBMITTED BY THE APPLICANT

- Completion of application for renewal of employment permit form. (Commonly known as "Questionnaire").
- 2. FORM 3-1/0033 Application for Visa
- 3. Motivation letter from employer
- Company profile / Audited Financial Statements / Social Security Registration of Employees list, Company Good Standing Certificate from Social Security Commission and Company Tax Certificate of Good Standing with Inland Revenue
- Personal Tax Certificate of Good Standing with Inland Revenue and Company registration.
- Copy of passport and last permit endorsed in the passport.
- Proof of current legal status in the country.
- Progress report on the training of Namibian citizen / Human Resource Development Plan / Replacement Strategic Plan. (Name of trainees and understudies with their contact numbers to be submitted)
- 9. Original Namibian Police Clearance Certificate
- 10. Proof of advertisements in at least three (3) local newspapers
- Name-list of all employees as well as their Social Security registration numbers.
- 12. Proof of Emplyment Equiity Compliance Certificate.
- 13. CV's and qualification of unsuccessful Namibian candidates.
