# REQUIREMENTS FOR SHORT TERM EMPLOYMENT PERMIT

Note: 1. incomplete forms and outstanding documents will cause unnecessary delays.

- 2. All documents must be in English or translated in English.
- 3. All documents must be certified.
- 4. Application forms must be signed by applicant (themselves)

#### 1. Short term Employment Permits

#### Category 1 (1-3 months)

- 1. Completion of visa application form (N.3-1/0033) signed by applicant
- 2. Accompanying, dependent must complete separate application form
- 3. Copy of passport and /or legal staus if in Namibia
- 4. Copies of qualifications
- Motivation letter from employer explaining in detail the purpose of work and why Namibians cannot be employed and/or supporting letter(s) from respective employer (s) /line ministries or bodies
- 6. Proof of tender /contract awarded
  - NB: 1. Filming- attach filming permit from Namibia filming commission
- 2. Media- attach accreditation letter from the Ministry of Information and Communication Technology
- 3. Tour operator -attach Namibia tourism board certificate from Ministry of Environment and Tourism

#### Categoy 2 (1-6 months)

- 1. Completion of visa application form (N.3-1/0033)
- 2. Accompanying, dependent must complete separate visa application form
- 3. Certified copies of passports (if in Namibia attach current status)
- 4. Certified copies of qualification and must be translated into English
- 5. Motivation letter from employer
- 6. Proof of tender/contract awarded
- 7. Proof of advertisement of the post in 3 three local news papers

- 8. Original police clearance from country of origin and must be translated in English
- 9. Radiological reports
- 10. Medical certificates
- 11. Filming application must attach filming permit from Namibia filming commission
- Media application must attach accreditation letter from the Ministry of Information and Communication Technology.
- 13. Tour operator application must attach Namibia tourism board certificate from Ministry of Environment and Tourism

# 2. BUSINESS VISA -1-3 MONTHS (persons attending business workshop/meetings/conference or exploring business opportunities)

- 1. Completion of visa application form (.3-1/0033) signed by applicant
- 2. If accompanying, dependent must complete separate visa application form.
- 3. Certified copies of passport
- 4. Invitation letter from host company or organisation.
- 5. Confirmed return ticket
- Proof of Namibian legal status of business partner as well as proof of registration of the company.

#### 3. HOLIDAY VISA 1-3 MONTHS

- 1. Completion of visa application form (N.3-1/0033) (signed by applicant)
- Each and every applicant should complete separate visa application form (N.3-1/0033) including minors
- 3. Certified copies of passport from country of origin
- 4. Invitation letter from inviter, if invited
- 5. Deed of surety form signed by inviter, if invited
- 6. Proof of confirmed return ticket
- 7. Six (6) months bank statement from inviter, if invited
- 8. Current status of inviter, if invited

#### 4. TOURIST VISA 1-3 MONTHS

- 1. Completion of visa application form (N.3-1/0033) signed by applicant
- Each and every applicant should complete separate visa application form (N.3-1/0033) including minors
- 3. Motivation letter from travel agency or from applicant
- 4. Proof of confirmed return ticket
- 5. Proof of accommodation (hotel bookings/resident)
- 6. Proof of financial statement for 6 months of applicant

#### 5. APPEAL APPLICATION

1. Prescribed fee: N\$ 200.00 must accompany your Appeal application
